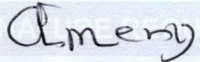

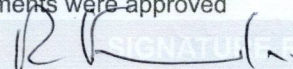

4 Staff Costs	10,487	12,396	1,909	18.20%	YES		The majority of the increase has been due to the Government's rise in National Insurance premiums, payable on the Clerks salary. This was more than we anticipated it would be and amounts to an increase of £870.85 over this accounting period, totalling £2972.58 this year compared to £2101.73 in the previous accounting year. The Clerks salary went up 1 SCP scale to £20.29 per hour. Additional costs have been holiday hours paid to the Clerk over and above the contracted 45 hours per month. This is because the Clerk cannot always carry out her duties within the restricted hours of 45 p.m. In 24/25 she was able to take all her holiday hours within the 45 hours per month limit. In 25/26 a total of 31 hours at £20.29 was paid over and above her 45 hours per month, totalling £629. The balance of £409 is due to the increase in the clerks salary as already stated from £19.66 p.h. to £20.29 p.h. from 1 April 2025.

6 All Other Payments	38,572	26,973	-11,599	30.07%	YES		In the previous accounting year 24/25, our expenditure increased by £18136 as we had significant project expenses. Those were major infrastructure projects that would not be repeated. As such, our expenditure is a lot less this financial year 25/26. CIL expenditure in this year amounted to £8847.45 which amounts to £9289 less than the previous year. Our street light costs have greatly reduced due to our investment the previous year in upgrading to LED lights, and this amounts to a saving of £971 from the previous year. Less significant savings have been made on some regular bills, but these do not amount to anything substantial.
